
When we could no longer host in-person events, we quickly pivoted to offering Virtual Events—giving our clients the chance to still connect with each other during some truly difficult times.

O&M teaches concepts, skills, and techniques necessary for a person with a visual impairment to travel safely and efficiently through any environment and under all environmental conditions.



In recognition of PPL's 100th anniversary this year, the PPL Foundation awarded a total of \$100,000 in grants to help illuminate the outstanding contributions of individuals working in the nonprofit sector. 
